## PRESIDENT'S OFFICE

### EXECUTIVE ORDER

#### *Excluding and Banishing Edward M. Kindt from Seneca Nation Territories*

- WHEREAS,** The Seneca Nation has the inherent right to exclude and banish individuals from the Territories of the Seneca Nation who cause harm or pose a threat to the health and safety of the Seneca Nation and its community members; and
- WHEREAS,** the President of the Seneca Nation has the authority, pursuant to the Constitution of the Seneca Nation, to enforce the laws of the Seneca Nation; and
- WHEREAS,** Seneca Nation member Edward M. Kindt, has been convicted of the felony of second degree murder; and
- WHEREAS,** Edward M. Kindt is currently subject to an Executive Order, dated March 28, 2023, which excludes and banishes Edward M. Kindt from the Territories of the Seneca Nation for a period of one year; and
- WHEREAS,** the one year exclusion and banishment shall expire on its own terms on March 28, 2024; and
- WHEREAS,** the President has reassessed whether Edward M. Kindt continues to pose a threat to the health and safety of the Seneca Nation and its community members; and
- WHEREAS,** the President has determined that Edward M. Kindt continues to pose a danger to the Seneca Nation and its community members.


**NOW THEREFORE BE IT ORDERED** that Edward M. Kindt's exclusion and banishment from the Territories of the Seneca Nation shall be continued for a period of one year; and be it

**FURTHER ORDERED**, that upon Edward M. Kindt's entry on to Seneca Nation Territories, the Seneca Nation Marshals' Office, in cooperation with local law enforcement agencies, is authorized and directed to remove him from the Territories and to continue to remove him should he return; and be it

**FURTHER ORDERED**, that Edward M. Kindt's exclusion and banishment from the Territories of the Seneca Nation will be reassessed by the Nation prior to the expiration of this one-year exclusion and banishment from the Territories.
