TO APPROVE EXCLUDING ALLEN D. ("AJ") LARKIN, JR., FROM SENECA NATION TERRITORIES

MOTION: by Rickey L. Armstrong, Sr., seconded by Clint Nephew that the Seneca Nation Council approves the following resolution:

WHEREAS, the Seneca Nation has the inherent right to exclude individuals from the Territories of the Seneca Nation who cause harm or pose a threat to the health and safety of the Seneca Nation and its community members; and

WHEREAS, it has been determined that Allen D. ("AJ") Larkin, Jr., a Seneca Nation member, has a longstanding, well-documented history of bringing harm to the Seneca Nation and presents an ongoing threat and danger to Seneca community members due to his engaging in extremely violent behavior, including numerous assaults resulting in bodily injury, and sex crimes, including indictments for Child Sex Abuse (where the victim is less than thirteen years old), Rape in the First Degree, Rape in the Third Degree, and Criminal Obstruction of Breathing; and

WHEREAS, the Nation Council has determined that the presence of Allen D. Larkin, Jr., on Nation Territory poses a clear and present danger to the Nation and its members, justifying the extraordinary step of compelling his exclusion from Nation Territory.

NOW, THEREFORE, BE IT RESOLVED, that Allen D. Larkin, Jr., is hereby excluded from all Seneca Nation Territories, effective immediately; and

BE IT FURTHER RESOLVED, that effective immediately all annuity payments, disability payments, any direct health and welfare payments, and any other payments from the Nation ("Direct Benefits") to Allen D. Larkin, Jr., are hereby forfeited; and

BE IT FURTHER RESOLVED, that should Allen D. Larkin, Jr. fail or refuse to leave within 48 hours of service by personal delivery or posting of a certified copy of this resolution, the Utilities Department is directed to take all necessary and appropriate steps to shut off those utilities provided to residences that Allen D. Larkin, Jr., lives at or frequents, including where said utilities use a Nation right-of-way; and

BE IT FURTHER RESOLVED, that any member of the Seneca Nation who is determined to have knowingly harbored or assisted Allen D. Larkin, Jr., to remain on or return to Seneca Nation Territory in violation of this resolution may be charged in the Seneca Nation Peacemakers' Court with aiding and abetting in violation of this resolution, with potential penalties including the forfeiture of Nation Annuity and other Direct Benefit payments; and

BE IT FURTHER RESOLVED, that any person holding an interest in the lease of Seneca Nation lands who is determined to have knowingly harbored or assisted Allen D. Larkin, Jr., to remain on or return to such leased premises in violation of this resolution may be charged with a breach of their lease, with potential penalties including lease termination; and

BE IT FURTHER RESOLVED, that upon Allen D. Larkin, Jr.'s entry into or presence on the Seneca Nation Territories in violation of this resolution, the Seneca Nation Marshal's Office, in cooperation with local law enforcement agencies, is authorized and directed to remove him from the territories and to continue to remove him should he return; and

BE IT FURTHER RESOLVED, that Allen D. Larkin, Jr., may petition the Council to have this resolution modified or rescinded no sooner than one year from the date of adoption hereof, or one year from the end of any sentence of imprisonment, whichever is later.
