TO APPROVE EXCLUDING MEGAN F. WHITE AKA MEGAN F. BOMBERRY FROM SENECA NATION TERRITORIES

MOTION: by Kevin Seneca, seconded by Joshua Becker, that the Seneca Nation Council approves the following resolution:

WHEREAS, the Seneca Nation has the inherent right to exclude individuals from the Territories of the Seneca Nation who cause harm or pose a threat to the health and safety of the Seneca Nation and its community members; and

WHEREAS, it has been determined that Megan F. White, a/k/a Megan F. Bomberry, a Seneca Nation member, presents an ongoing threat and danger to Seneca community members due to the fact that she has been charged with murder in the second degree, manslaughter in the first degree, and assault in the first degree, in relation to the murder of a resident of the City of Salamanca; and

WHEREAS, the Nation Council has determined that the presence of Megan F. White on Nation Territory poses a clear and present danger to the Nation and its members, justifying the extraordinary step of compelling her exclusion from Nation Territory.

NOW, THEREFORE, BE IT RESOLVED, that Megan F. White is hereby excluded from all Seneca Nation Territories, effective immediately; and

RESOLVED, that effective immediately all annuity payments, disability payments, any direct health and welfare payments, and any other payments from the Nation ("Direct Benefits") to Megan F. White are hereby forfeited; and

RESOLVED, should Megan F. White return Seneca Nation Territory after service by personal delivery or posting of a certified copy of this resolution, the Utilities Department is directed to take all necessary and appropriate steps to shut off those utilities provided to residences that Megan F. White lives at or frequents, including where said utilities use a Nation right-of-way; and

RESOLVED, that any member of the Seneca Nation who is determined to have knowingly harbored or assisted Megan F. White to remain on or return to Seneca Nation Territory in violation of this resolution may be charged in the Seneca Nation Peacemakers' Court with aiding and abetting in violation of this resolution, with potential penalties including the forfeiture of Nation Annuity and other Direct Benefit payments; and

RESOLVED, that any person holding an interest in the lease of Seneca Nation lands who determined to have knowingly harbored or assisted Megan F. White to remain on or return to such leased premises in violation of this resolution may be charged with breach of their lease, with potential penalties including lease termination; and

RESOLVED, that upon Megan F. White's entry into or presence on the Seneca Nation Territories in violation of this resolution, the Seneca Nation Marshal's Office, in cooperation with local law enforcement agencies, is authorized and directed to remove her from the Territories and to continue to remove her should she return; and

BE IT FURTHER RESOLVED, that Megan F. White may petition the Council to have this resolution modified or rescinded no sooner than one year from the date of adoption hereof or one year from the end of any sentence of imprisonment, whichever is later.


